

Ujeedada ogeysiiskani waa in lagu wargaliyo waalidka/daryeelayaasha iyo ardaydaba xuquuqdooda Qayba Xeerka Dhaqan-celinta lambarka 504 ee 1973, Qaybta dufcada (Section 504 of the Rehabilitation Act of 1973). Qaybta 504 waa xeer madani ah kaasoo mamnuucaya midab takoor sababo naafanimo. Special School District No.1, Minneapolis Public Schools, waxay idin siinaysaa waalid ahaan ama daryeele arday u, iyadoo la raacayo hanaanka xuquuqda soo socota.

1. Waxaad xaq u leedahay inaad hesho nuqul ogeysiiskan ah marka degmadu tilmaanta, qiimayso, diiddo inay qiimayso, sameeyaan meelayn tacliimeed cusub, diiddo meelayn tacliimeed cusub, ama ay samayso isbeddel muuqda ee meelaynta cunugaaga sababo la xiriira naafadiisa.
2. Waxaad xaq u leedahay in la qiimeeyo cunugaaga hadii degmadu ay hayso sabab ay ku rumeeyaan in cunugaagu qabo naafo maskaxeed ama dhimireed/jireed, taasoo si xooggan uga xadidaysa waxqabadyada noloshu waaweyn. Waxaad xaq u leedahay qiimayntaasi inta aan qorshe kasta ee degaan la samayn iyo inta aan isbeddel ahmiyad weyn leh la samayn, qorshaha meelaynta cunugaaga. Tusaale ka mid ah isbeddelka meelaynta tacliimeed ahmiyadda weyn leh waa in loo diro eryid/burin/cayrin .
3. Cunugaagu wuxuu xaq u leeyahay tacliin bilaash ah oo ku habboon. Waxaad mas'uul ka tahay si taa la mid ah kharajka waalidka/daryeelayaasha carruurta aan naafada qabin. Waxuu noqon karaa (Tusaale ahaan qarashka safarka ama hadii buuggaag la siiyey oo uu cunuggaagu dhumiyey)
4. Inta xadka ugu macquulsan, cunugaagu wuxuu xaq u leeyahay in wax loo baro sida kuwa aan naafada qabin ee facooda/kufkooda/isaagooda ( non-disabled peers).
5. Waxaad xaq u leedahay inaad fiirisid dhammaan ndiiwaanada laga qoray cunuggaaga ee dugsiya yaala.
6. waxaad xaq u leedahay hanaan dhegaysi aan eex lahayn/daacad ah hadii aad doonayso inaad la beratanto wixii khuseeya cunugaaga aqoonsigiisa, qiimaynta, adigoo tixraacaya Qaybta 504. Waxaad xaq u leedahay inaad qof ahaan uga qayb qaadata dhammaan dhegeysiyada, ama garyaqaan ku matala, hadii aad doonayso inaad mid qabsatid qareen.
7. Haddii aad doonayso inaad u loolanto/baratanto tallaabo ay qaaday Koox qaybta 504 adigoo ula jeeda hanaan dhegaysi aan eex lahayn/daacad ah/garsoor leh, waa waajib inaad soo gudbiso Ogeysiis Racfaan ama ka codsato Dhegaysi Xiriiriyaha Degmada Qaybta 504 (Notice of Appeal or a Request for Hearing to the District's Section 504 Coordinator at:
